The School Board of Trustees of School District No. 6 met in the district board room on Tuesday, October 30, 2012.

CALL TO The meeting was called to order at 5:15 pm by Chairperson Suzette Cain.

TRIP APPR. to Indianapolis for the FFA Advisor, Students and Chaperones. All voted in favor.


STDNT. EXP. Due to the student J.L. absent Board Chair left the meeting open for the student expulsion.
